Part E.4. – WellStar is reporting only ED beds dedicated for trauma and patients that qualify for the Trauma Registry. WellStar Douglas Hospital was not a designated trauma center in 2018 and thus had no dedicated ED trauma beds or trauma registry volume. WellStar previously reported trauma volumes based on ICD coding. Using ICD-10 codes, Douglas Hospital had 10,570 trauma visits in 2018. The hospital used ICD10 codes to determine Psych patients, used 0-17 for Peds patients, and all other were General ED beds for survey reporting purposes. The visit data reflect the types of cases that relate to the described bed/room type, regardless of where in the emergency department the patient visit took place. Part F.1.b Hospice counts show Hospice patients in a hospital bed, and do not show activities of Wellstar owned hospice facilities.

G.3 Physicians who do not identify a race are listed as multi-racial.
