Part E4: Trauma Registry codes are used to determine Trauma volumes in the ED. ICD-10 codes are utilized to determine psych ED volumes. Patients ages 0-17 are considered pediatric patients treated in pediatric beds. All other patients are considered treated in general ED beds for survey reporting. Utilization volumes are based on the type of clinical encounter, regardless of where within the ED the encounters take place.
