



# WELLSTAR MCG HEALTH HEALTH-SYSTEM PHARMACY ADMINISTRATION & LEADERSHIP RESIDENCY PROGRAM WITH MBA

Wellstar MCG Health Medical Center at Augusta University, home of the Medical College of Georgia (MCG) provides a 24- month (104 week) PGY1/PGY2 Health-System Pharmacy Administration and Leadership (HSPAL) Residency, which is offered in conjunction with a Master of Business Administration (MBA) through Augusta University Hull College of Business. Residents will complete the PGY1 year along with the other five (5) residents in the PGY1 Pharmacy Residency Program. Candidates who have already completed a MBA have the option to pursue a Master of Public Health degree at Augusta University.

This post-graduate experience provides comprehensive training in acute care, ambulatory care, drug information, medication-use policy development, practice management, teaching and research. The program is flexible to meet individual residents' specific needs and interests. Residents participate in pharmacy coverage (rotating schedule, weekends and evenings) and are responsible for completing a research project suitable for publication in a professional journal. This program was established to train the future leaders of our profession by providing them with tools and knowledge to lead patient-centered care in a dynamic health care environment. The PGY1 program will focus on foundational comprehensive clinical training, with the PGY2 focused on pharmacy administration and leadership. Five decades of WMCG Pharmacy Residency graduates continue to make us proud by "making a difference" in a variety of practice settings.

#### MISSION OF OUR RESIDENCY PROGRAMS

To create residency graduates who are competent, confident, and compassionate pharmacy practitioners who are active members of the health care team and positioned to be leaders, educators, and researchers in the profession.

#### **PGY1 RESIDENCY PROGRAM PURPOSE:**

PGY1 residency programs build upon Doctor of Pharmacy (PharmD) education and outcomes to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives. Residents who successfully complete PGY1 residency programs will be skilled in diverse patient care, practice management, leadership, and education, and be prepared to provide patient care and seek board certification in pharmacotherapy (BCPS).

#### **PGY2** RESIDENCY PROGRAM PURPOSE:

A PGY2 health-system pharmacy administration and leadership residency builds upon PGY1 residency graduates' competence in the delivery of patient-centered care and in pharmacy operational services to prepare residents who can assume high level managerial, supervisory, and leadership responsibilities. Areas of competence emphasized during the program include safe and effective medication-use systems, quality assurance and improvement, the management of human resources, the management of financial resources, use of technology, and advanced leadership. The residency lays the foundation for continued growth in management and leadership skills.

Upon graduation, residents are prepared for a clinical or operational management/supervisory role in a variety of work settings. Often, our residency graduates will also assume substantive precepting and/or teaching responsibilities. They will be leaders and change agents at their practice sites and for the profession.

#### PHARMACISTS PRACTITIONERS AND LEADERS WHO MAKE A DIFFERENCE

Pharmacists completing this residency will be competent, confident, and compassionate pharmaceutical care providers across the continuum of patient care. They will be accountable for achieving optimal drug therapy outcomes as active members of the health care team. These pharmacists will exercise skills in educating patients, consumers, other health professionals and the next generation of pharmacists. They will serve as a role model by contributing to improved pharmacy services and patient outcomes in their practice setting. Through self-evaluation and improvement, they will grow professionally throughout their career.

#### **Program Schedule**

The residency program begins in July and lasts 24 months (104 weeks).

#### **Compensation and Benefits**

Residents enjoy a competitive stipend and generous benefits package including accrual of approximately twenty-four days paid-time-off (PTO) as well as professional leave days for meeting attendance, individualized subsidized insurance starting day 1, free parking, and contributions to a 403-b retirement plan. The program pays resident travel expenses and registration fees to attend the ASHP Midyear Clinical Meeting, the Southeastern Residency Conference, and GSHP Resident Research Day. The Wellstar MCG Pharmacy Department also pays tuition and school fees (excluding textbooks) for the Augusta University Master in Business Administration program.

#### **Application Process**

Applications are submitted electronically through the Pharmacy Online Residency Centralized Application Service (PhORCAS). Deadline for receipt of applications is January 2; however, early application is encouraged. On-site interviews are offered to a limited number of applicants based on review of the completed application in PhORCAS.

Applicants must possess a Pharm.D. degree from an ACPE-accredited college or school of pharmacy and must be eligible for licensure as a pharmacist in the State of Georgia.

**Application Material Includes:** 

- 1) Standardized application through PhORCAS (including letter of intent, CV, etc.)
- 2) At least 3 professional references through PhORCAS
- 3) Transcripts (only pharmacy school-related coursework must be submitted)

#### **HEALTH SYSTEM PHARMACY SERVICES**

The Department of Pharmacy provides pharmaceutical care to patients and comprehensive services to
physicians and other health care professionals as an integral part of the teaching, research, and patientcare programs of the clinical enterprise. The Pharmacy Department's activities are enhanced by
integrated state-of-the-art computerized information systems, and automation from carousel central
inventory management to the latest unit-based cabinets and smart infusion pumps.

Pharmacy services are available at a variety of locations around campus:

- The inpatient **Central Pharmacy** is the primary production area. The medication distribution process is highly automated with MedCarousel technology for refilling over 90 automated dispensing cabinets throughout the medical center that provide immediate access to over 85% of doses. There are multiple daily unit-dose medication fill lists for pediatric patients requiring individualized doses. The packaging and manufacturing area prepares unit doses from bulk containers, compounds a variety of dosage forms, and flavors pediatric oral liquids. Large-volume parenterals, minibags, total parenteral nutrition solutions, and chemotherapy are aseptically prepared in a USP797-compliant IV clean room.
- A Satellite Pharmacy in the Children's Hospital of Georgia (CHOG) meets the immediate needs of pediatric, critical care and emergency department patients seven days a week. This area prepares individualized doses and IV batch preparation for pediatric patients, as well as pediatric and neonatal parenteral dilutions in a USP797-compliant IV clean room.
- Unit-Based Pharmacists cover hospital inpatient units. They provide clinical pharmacy support to the
  medical and nursing staffs including pharmacokinetic consulting and drug choice recommendations.
  They also participate in a variety of direct patient care services including participation in
  multidisciplinary rounds, medication counseling, Code Blue response, renal dose adjustments and
  therapeutic drug monitoring. Pharmacists work with their retail counterparts and Meds-to-Beds
  pharmacy technicians to promote seamless transitions in care.
- The Medical Office Building Pharmacy provides pharmacy services to one of the largest ambulatory care centers in the southeast. An Employee Pharmacy opened in late fall 2012, Specialty Pharmacy services were implemented in 2014 and a Retail Pharmacy that has a discharge prescription program with transitions in care management and delivery to the patient's bedside (meds-to-beds program) opened in May 2015. The retail pharmacy also coordinates with prescribers to provide Patient Assistance Program drugs.
- Therapeutic Policy/Formulary Management/Drug Information Pharmacists proactively provide pharmaceutical and drug therapy information to health care practitioners. Pharmacy and Therapeutics Committee activities, formulary management, medication policies and clinical guidelines, and the medication use evaluation (MUE) program are coordinated through members of the Pharmacy Leadership Team.
- Antimicrobial Stewardship pharmacists work closely with our Infectious Disease service and Epidemiology to optimize use of anti-infective agents and minimize the development of antibiotic resistance in both adult and pediatric patients.
- The Georgia Cancer Center Pharmacy prepares chemotherapy and supportive care medications for administration to ambulatory patients with cancer and provides services for a Cancer Clinical Research Unit (Phase I and Phase II clinical trials). The pharmacy features a USP797 and USP800 compliant hazardous IV cleanroom. The pharmacy is adjacent to the infusion area, which facilitates interactions and patient education. Augusta University and Wellstar MCG Health are pursuing an initiative to be recognized as an NCI-designated Cancer Center and this is one of only 14 NCI Community Oncology

Research Program Minority/Underserved Community Site grantees (NCORP) nationally (see <a href="http://ncorp.cancer.gov">http://ncorp.cancer.gov</a>). In 2017, a **Clinic-based Oncology Pharmacist** began developing services for the solid-tumor cancer patients seen for non-infusion related treatment and continuity of care and a second pharmacist was added in 2023. A pair of pharmacists cover the continuity of care for **BMT/CAR-T** and other cellular infusions (one inpatient and the second, primarily ambulatory, was added in 2022).

- Emergency Medicine Pharmacy Services for the Adult and Pediatric Emergency Rooms are provided 7 days a week by 5 pharmacists and numerous medication history pharmacy technicians. Pharmacists participate in bedside medication preparation and administration, medication therapy optimization, antimicrobial stewardship, toxicology, and management of medical emergencies. They also promote safe and effective medication use through protocol and guideline development and interdisciplinary education.
- Renal Transplant Clinic provides multidisciplinary and collaborative care to patients before and after solid organ transplant and evaluation of donors and recipients. Two pharmacists are dedicated full time to the growing Solid Organ Transplant program (both inpatient and ambulatory care).
- Ambulatory-based Pharmacist Clinicians, who operate under collaborative practice agreements, are part of the care teams in the Family Medicine Center, Internal Medicine Clinic, Pediatrics, Oncology Solid Tumor Clinic, Cardiology, Population Health, and the Digestive Health Center. Family Medicine is recognized as a level-three Patient-Centered Medical Home and additional population health efforts are underway in adult primary care and pediatrics. The Anticoagulation Clinic is a pharmacist-run collaborative practice site. A fulltime pediatric pharmacist and fulltime adult pharmacist are part of the Pediatric and Adult Cystic Fibrosis teams.
- The Clinical Research Pharmacy provides study medication management and research support services
  for over 200 inpatient and outpatient protocols. Pharmacists are involved on both biomedical IRBs
  (including a pharmacist Chair for the cancer-focused IRB), and two pharmacists serve on the PRMC –
  the scientific review committee for the Georgia Cancer Center.
- Pharmacy services are provided to the Georgia War Veterans Nursing Home (GWVNH), a 188-bed long-term care facility on campus. Consultant services include attendance at admission interviews, developing a pharmacy care plan, monitoring therapy outcomes and recommending pharmacotherapeutic options. The Pharmacy provides unit dose drug distribution, drug information and a medication use evaluation program.
- Wellstar Columbia County Medical Center, an infusion center and adjacent medical office building
  open in August and September 2026 respectively. This full-service 100 inpatient beg acute care facility
  will bring the world-class care already provided at Wellstar MCG Health to the residents of Columbia
  County and the surrounding areas.
- Education and Training Programs of the Pharmacy Department include ASHP-accredited PGY1, PGY2 Pediatric, Critical Care, Ambulatory Care, PGY1-PGY2 HSPAL, and Infectious Diseases residencies, numerous IPPE and APPE (clerkships) for the University of Georgia Pharm.D. Program, pharmacy intern experiences, and ASHP-accredited technician training rotations in conjunction with two technical colleges. Pharmacy practitioners hold academic appointments with the University of Georgia College of Pharmacy as Clinical Faculty and/or Preceptors. "Pharmacy Grand Rounds" is a weekly ACPE-accredited educational seminar sponsored by the residency program and the Georgia Society of Health-System Pharmacists. The Pharmacy Department also jointly sponsors monthly Adverse Drug Reaction Conferences in the adult hospital (with the Department of Medicine) and in the children's hospital (with the Department of Pediatrics). Our department has a strong commitment to ongoing pharmacy preceptor development and our teaching mission.

#### **COLLEGE OF PHARMACY CONNECTION**

**University of Georgia (UGA) College of Pharmacy** has full-time faculty located in Augusta on the Wellstar MCG Health/Augusta University campus. The faculty participate in pharmacy services as part of their research, education, and training activities. The College of Pharmacy is an active partner in the pharmacy residency program. Pharmacy residents participate in classroom teaching locally and via video link and are involved with mentoring of pharmacy students in Augusta. Residents receive an appointment at UGA College of Pharmacy for their teaching/precepting.

#### Overview

The University of Georgia College of Pharmacy offers the Doctor of Pharmacy professional degree. Based in Athens, Georgia, the college admits about 150 students a year. The four-year professional program integrates classroom, laboratory and experiential training in a curriculum organized around both human physiology and disease states. Thirty students from each class spend the last 2 years of their program on the Augusta extended campus with another 10 coming for the 4<sup>th</sup> year clinical rotations. The college also offers graduate studies in disciplines associated with pharmacotherapeutic research, clinical and experimental therapeutics, and administration.

#### History

The College of Pharmacy was founded in 1903. In 1926, seven years before a degree was required for licensure, the college adopted a four-year Bachelor of Science program. Since that time the college has remained on the cutting edge of pharmacy education. State-of-the-art two-way interactive video links our Augusta campus to faculty and students in Athens, Albany and Savannah. The UGA College of Pharmacy has also been a leader in implementing online instruction and providing students with earlier practice experience opportunities.

#### **Clinical and Administrative Pharmacy**

The Department of Clinical and Administrative Pharmacy offers clinical training in many areas through clinical sites in Athens, Augusta (at Wellstar MCG Health), Savannah, and Albany. Faculty work in a diverse array of patient care sites from primary care clinics and community pharmacies to large, tertiary-care hospitals. The Department offers PhD degrees in Clinical and Experimental Therapeutics and Pharmacy Care Administration. The Center for Pharmacy and Experimental Therapeutics at the Medical College of Georgia facilitates research and teaching collaborations between UGA and Augusta University.
